The NhRP's groundbreaking work to date has focused on bringing habeas corpus petitions to challenge the wrongful confinement of nonhuman animals in places like laboratories and zoos. Science tells us that the biological and social needs of many species simply cannot be met in captivity: their instincts and natural behaviors are inseparably tied to an appropriate habitat and the freedom to make their own decisions. Science also tells us that many species have some comprehension of the past and the future, and that, like humans, members of these species suffer immensely in captivity because they can anticipate that their confinement may be never-ending.

The writ of habeas corpus has existed for centuries and is meant to protect anyone unjustly imprisoned. NhRP petitions—which have resulted in the world's first-ever habeas corpus hearings on behalf of nonhuman animals—argue that common law courts must recognize our nonhuman animal clients as legal persons with the fundamental right to liberty protected by the writ of habeas corpus, and then order their release to a sanctuary, where this right will be respected.

NhRP cases have provided nonhuman animals with access to our justice system that they wouldn't otherwise have had. The NhRP made history and headlines in 2022 when the New York Court of Appeals—one of the most influential state courts in the US—agreed to hear the NhRP's case on behalf of Happy, an elephant living in solitary confinement at the Bronx Zoo. This marked the first time the highest court of any English-speaking jurisdiction heard a habeas corpus case brought on behalf of a nonhuman being.

In 2024, the NhRP presented oral arguments before the Colorado Supreme Court on behalf of five elephants at the Cheyenne Mountain Zoo, only the second U.S. state high court to take up the question of the right to liberty for nonhuman animals. In 2025, the Michigan Court of Appeals heard and rendered a decision in our case on behalf of the chimpanzees held captive at the DeYoung Family Zoo, a case supported by world-renowned primatologists including the late Jane Goodall. We also filed new habeas corpus petitions in Los Angeles and Pennsylvania, bringing the question of elephant liberty before courts in both states for the first time. In Pennsylvania, those filings led to hearings and, in early 2026, the third habeas corpus order for a nonhuman animal in U.S. history.

The NhRP's persistence and bold approach are changing the legal status quo and have catalyzed a global conversation about how our legal systems view and treat nonhuman animals. As a result, courts and legislatures around the world are beginning to recognize the systemic problem of animals' rightlessness, the suffering it has caused, and the ways it undermines the values and principles of justice on which our own human rights depend.

Public Engagement: In 2024, the NhRP launched a public opinion research initiative designed to strengthen its work inside the courtroom by informing how its legal arguments are understood and received outside of it. In 2025, the NhRP completed both quantitative and qualitative polling and applied the results to inform its litigation, communications, and broader strategic approach.

This work generated data on public attitudes toward legal rights for nonhuman animals and identified the narratives, comparisons, and terminology that are most effective across political, demographic, and value-based segments. Through qualitative research with legal professionals, the NhRP learned which arguments are viewed as most persuasive and legally viable, while also identifying language that may alienate or confuse key audiences.

The NhRP uses these results to guide its litigation strategy and refine its public messaging. Using current data as benchmark metrics, the NhRP can also track how its work impacts attitudes over time, particularly within the legal community.

Legal Community Education and Engagement: To expand opportunities for success in its rights-based litigation, the NhRP works to normalize the concept of legal rights for nonhuman animals within the legal community. This includes targeted engagement in jurisdictions where the NhRP has active or anticipated litigation, with the goal of increasing familiarity with and consideration of the legal, social, historical, scientific, and justice-based foundations of its arguments. The NhRP’s 2025 polling data helped to refine its outreach to these audiences.

The NhRP also directly engages the judicial system beyond its own cases by proactively identifying and pursuing opportunities to file amicus curiae briefs in cases where, even if no explicit question of nonhuman animal rights is presented, some aspect of the legal status of nonhuman animals is at issue. For example, in 2025, the NhRP filed an amicus brief in a California case involving the use of the necessity defense in the context of animal rescue, asking a court to recognize that animal cruelty qualifies as a "significant evil" that may justify emergency intervention.

Engagement of this kind creates opportunities to build common ground with judges, attorneys, and legal scholars who may recognize shortcomings in the legal system’s treatment of nonhuman animals, even where they have not yet considered the recognition of legal rights.

Broader Community Education and Engagement: Engaging with the broader public on legal rights for nonhuman animals is also a key part of the NhRP's strategy, since judges and other decision-makers reflect the societal beliefs and values of their communities. The NhRP focuses this engagement in communities with active NhRP litigation, using earned and paid media, online organizing, and events to educate more people about the importance of These efforts will also be boosted in 2025 through analysis of data collected during the ongoing polling project. Public response to NhRP efforts has been vibrant and visible in part because of the novelty of NhRP’s work. As an example, when supporters in NY noticed in 2024 that NhRP client Happy the elephant was no longer visible, the NhRP publicly called on the Bronx Zoo to explain why Happy was being denied access outdoors. Over a multi-week campaign, the NhRP sponsored a series of actions that generated global media coverage about Happy's situation, providing a platform for the NhRP to talk very loudly about nonhuman animal cognition, the mental and physical suffering autonomous nonhuman animals endure through exploitation, and the importance of rights.
